



AGREEMENT AND RELEASE 2026

I. I agree to release Holy Family Catholic High School, from any and all claims and legal responsibility including but not limited to the following:

1. Personal injury, death, loss, damage, accident or property damage arising from my son's/daughter's participation in the "HF Greece Trip 2025" program regardless of nature or cause.
2. Loss of passport, airline tickets, luggage, personal belongings regardless of nature or cause.
3. Expenses and consequences arising from the conduct of the participant, and/or violation of our "code of conduct" including but not limited to drinking alcohol, using illegal drugs, engaging in sexual or romantic acts, leaving the premises of the hotel/home without permission or unaccompanied, getting a tattoo or body piercing, using a motorized vehicle, carrying or purchasing any weapons and/or participating in extreme sports or activities and/or engaging in any risky behavior.
4. Expenses arising from airline delays or cancellations, acts of God or nature, war, strikes, government restrictions, terrorism or any other person or company not controlled by Holy Family Catholic High School.

II. I agree that my son/daughter may be sent home without an escort, at my own expense and without a refund granted from Holy Family Catholic High School, if my son or daughter smokes, drinks alcoholic beverages, uses any illegal drugs, engages in sexual or romantic acts, leaves the premises of the hotel/home without permission or unaccompanied, gets a tattoo or body piercing, uses a motorized vehicle, does not cooperate with teachers and/or guides, carries or purchases any weapons, engages in any risky behavior, and/or participates in extreme sports or activities. This applies from the moment my son/daughter joins the group at the airport in the United States, to the completion of the return flight at the airport of origin in the United States.

III. I agree that this is a supervised program and I agree that my son/daughter is subject to the authority of the HF chaperones at all times. I understand that my son/daughter may be disciplined by the HF chaperones, local authorities, or any combination thereof.

IV. I agree that if my son/daughter becomes ill or incapacitated, HF chaperones may take whatever action deemed necessary to preserve my son's/daughter's health and safety including, without limitation, obtaining medical treatment and/or transporting my son/daughter back to my home country for medical reasons and pay for the expenses incurred because of that health/safety. I also agree to forfeit all program moneys paid due to my son's/daughter's illness or incapacity.

V. I agree that Holy Family Catholic High School, HF chaperones are not responsible for my son's/daughter's well-being when he/she is absent from supervised activities.

VI. I agree that any film or video likenesses taken of my son/daughter while participating in the program may be used in future publications produced by Holy Family Catholic High School.

VII. I agree that I am solely responsible for obtaining and making sure that my son/daughter carries the proper travel documents, and if my son/daughter is not a U.S. citizen, the appropriate visas for countries he/she is to visit, and the proper documents to re-enter the US.

I understand that it is my responsibility to ensure that my son/daughter has received the required immunizations for the trip.

I understand that by signing this document I am accepting all financial obligations for the trip including travel, chaperone costs, visas, safari fees and miscellaneous fees in the amount of the trip whether or not my son/daughter goes on the trip.
